Minutes of the previous meeting

The Council have secured the Groathill site the ownership of which is in dispute.

Police Scotland Report

- There has been less crime involving housebreaking over the last month but it is Drylaw's number one priority.
- Several youths have been arrested and charged in the for housebreaking related crimes. These are a variety of different individuals, there isn't one cohesive group.
- The Police still consider the helicopter to be a good tool.
- Cllr Barrie requested that we be informed when and why the helicopter is up. The police responded that they would be happy to inform us after the event the purpose of the activity.

- The CC asked if the police could increase officer patrols, the impression being that we only see officers after a crime has been committed. The police responded that this request would be passed up the chain of command.
- Cllr Hinds asked the police if they were able to deal with the pavement parking on Telford

Road. Although sympathetic, the police responded that the crime was one of driving on the pavement, not parking on one and as such was difficult to catch someone in the act.

- The CC asked the police if they were able to provide support for a proposal to install CCTV on the Groathill cyclepath. The police offered to make available crime figures and supporting evidence to the Council in which would contribute to resourcing decision.

Chair's Report

- Attended INP meeting and reported the following regarding the recent spate of housebreaking:

- Police resources are currently concentrated in Pilton.
- The Council currently pay for some additional police officers under a service level agreement as well as a crime analyst.
- Edinburgh has higher housebreaking rates than other parts of Scotland.

- Reported that the Edinburgh Association of Community Councils AGM is on the 31/05.
- As there are funds available for the EACC, IH is in favour of disbanding the EACC in favour of a good quality website.

- New committee members are to be voted in at the AGM and IH will forward candidates' CVs.

Secretary's Report

- Communications and conversations via the Secretary's email It was agreed that for the time being the Secretary will forward all incoming mail to the CBCC email account to the CC committee.

- Curbside weeds Various members reported an increase on weeds growing at the curbside and on pavements. Councillors responded that while sympathetic, the Council currently has limited resources to tackle the problem. This is coupled with the requirement to use an environmentally friendly herbicide that is weaker than the traditional one and requires periods of dry weather, which we have not had recently. The Councillors will, however, look into what further can be done.

- Litter Alan Denham reported that the quantities of litter and other detritus, such as leaf matter in the gutters was at an unacceptable level. Cllr Hinds will look into this and has already asked that each area have parked cars removed in order that gutters are cleaned periodically.
